VOVINAM ST MARTIN TERMS & CONDITIONS

It is a condition of enrolment that members are aware of and agree to abide by the Vovinam St Martin terms and conditions. Read it carefully and do not sign it unless you are satisfied that you understand it. If you have any questions, please ask your branch representative.

LIABILITY: All members and their guests use Vovinam St Martin facilities at their own risk. Vovinam St Martin cannot accept responsibility for damage or injury through use of any facility. Furthermore, Vovinam St Martin is not responsible for any lost or stolen items, or damage to property or vehicles. Damage to Vovinam St Martin property must be paid for by any member who wilfully or negligently causes such damage. Members are responsible for damage caused by their guests or children.

TRAINING FEE TERMS & CONDITIONS: Training fees are based on 4 school terms, 10 weeks of training per term. Term fee must be paid within first month of the term. There is no refund for training fee, insurance fee or membership fee.

ADDITIONAL FEES AND CHARGES: Additional fees and charges required for belt testing, uniform purchases, equipment purchases, seminars, club events and competitions.

PRICE INCREASES AND MEMBERSHIP TERMS AND CONDITIONS CHANGES: One months' notice in writing will be provided prior to any price increase. The new conditions will become effective immediately after the date outlined in any correspondence. Terms and Conditions are subject to change without notice; an updated copy will be displayed at information desk.

INSURANCE: Insurance is compulsory for all members through our training centre insurance provider. Policy and claims information is available from the information desk. Claims must be made directly to the insurer, not Vovinam St Martin, within 30 days of the incident. The incident must be recorded on an Accident Report Form at the time it occurs. Student accident insurance is not intended to replace members' own medical / hospital benefit insurance.

CHANGE OF ADDRESS: We ask that members notify us of a change of mailing address, email address or telephone numbers as soon as possible. It's essential that you keep this information up-to-date so that we can contact you if necessary or in an emergency.

DUTY OF CARE: All children are to be adequately supervised by an appropriate adult before and after class. Vovinam St Martin Instructors are unable to provide supervision outside of the training hall.

CONFIDENTIALITY: A member cannot solicit any other student member or staff member in the business of Vovinam St Martin or a business of a similar nature. Members will not disclose or discuss any information pertaining to a student member, staff member or management that is of a personal or confidential nature. Any information that forms part of the Vovinam St Martin systems, including the student syllabus, programs, drills and games, remains the intellectual property of Vovinam St Martin and is not to be reproduced, republished on the internet, re-engineered, used or discussed outside of your membership. If any of these terms are broken, Vovinam St Martin will seek an injunction of trade and take legal action for monetary damages.

MANAGEMENT RIGHTS: The Management of Vovinam St Martin reserve the rights to cancel the rights of any member not complying with conditions of membership or codes of conduct, with no reason or refund. This will include publicly criticising the club, morally or criminally.

VOVINAM ST MARTIN WAIVER: Members, their parents or legal guardians realise that sometimes injuries may occur while doing Martial Arts and sports due to accidents. They will not hold Vovinam St Martin, its Instructors or event organisers and helpers responsible for any injuries that may occur and agree to Vovinam St Martin staff seeking medical help or administering first aid in the case of injury as deemed appropriate. Costs associated with the injury will be the responsibility of the member, parent, or legal guardian.

PERSONAL CONDUCT: To foster a pleasant and relaxed atmosphere, we ask members to conduct themselves in a responsible, polite, and calm manner. Members are asked to be punctual to classes and if any member is late, they will be asked to remain quietly at the hall door until invited into the class by an instructor. Bad language and rude behaviour will not be tolerated under any circumstances.

ATTIRE: All members are required to wear a Vovinam St Martin uniform that is clean and pressed. Hair, fingernails are to be trimmed and clean. Jewellery is not to be worn when training.

PHOTOGRAPHY: Photographs are taken regularly of student activities for members' use. These may at times be used for promotional or advertising purposes. Please advise Vovinam St Martin if you do not want your photos to be published.
